### **IPPTA Membership Application Document**

#### **Notice:**

*In accordance with clause 10 of the IPPTA constitution all official communication shall be in English. When providing IPPTA with your required documents we appreciate an English version where existing.*

#### **Membership information**

Criteria for membership:

The IPPTA membership shall be composed of private physiotherapy special interest groups recognised by the World Physiotherapy member organisation in that country. World Physiotherapy member organisations (World Physiotherapy MO) without a national private physiotherapy special interest group may be members of IPPTA under the following circumstances:

- a) The World Physiotherapy MO has members that are owners of private physiotherapy facilities and/or
- b) The World Physiotherapy MO has members that are delivering physiotherapy services in the private physiotherapy facilities.

#### **Payment details**

- a) Each Member Organisation shall pay an annual membership fee determined by the Executive Committee.
- b) In accordance with article 9.2 of the constitution subscriptions are due within two (2) months of the commencement of the financial year and are payable in the currency stipulated by the Executive Committee.
- c) Article 9.3 stipulates that the financial year of IPPTA shall be from 1 January to 31 December (calendar year).
- d) In accordance with article 4.5.1 of the constitution membership ceases if the current year's subscription is not paid by April 30th of the year in which the subscription becomes due.

#### **Membership fees**

The IPPTA subscription fee for membership is determined by the number of individual private practitioner members of the private practice special interest group or the number of private practitioner members of the national organisation.
